3.4 Test conditions:

- 1. A test probe with a diameter of 1mm was used to probe the gap part of the sample with a test force of 1N;
- 2. The sample was placed in a laboratory with a talc content of 2 kg per cubic metre of laboratory volume. During the test, the sample was kept in a vacuum state with a maximum pressure difference of 2kPa and an extraction rate less than 40 times the shell volume per hour. The test lasted eight hours.

3.5 Decision Basis:

The test probe cannot puncture any openings or gaps in the sample;

The protection is satisfactory if no deposit of dust is observable inside the enclosure at the end of the test.



In general, if any water has entered, it shall not:

- be sufficient to interfere with the correct operation of the equipment or impair safety;
- deposit on insulation parts where it could lead to tracking along the creepage distances;
- reach live parts or windings not designed to operate when wet;
- accumulate near the cable end or enter the cable if any.


